

Digital Government Exchange 2017 Seizing the Opportunities of Digital Disruption

Held from 2 to 4 May 2017, the Digital Government Exchange (DGX) is a closed-door dialogue among a group of leading international Government CIOs and public sector leaders for mutual learning and sharing. In its second year, the exchange facilitated by Singapore deep dives into the building of digital capabilities within governments, harnesses international case studies on public project delivery, and facilitates learning on how Smart Cities efforts have impacted and improved citizens' lives internationally.

As part of our Smart Nation drive, Singapore's move towards a Digital Government brings greater need to nurture internal capabilities and tap on emerging technologies and methodologies in order to deliver better citizen-centric digital solutions and services. The DGX 2017 will see attendees from leading digital governments of the world, namely Australia, Denmark, Estonia, Finland, Israel, Japan, New Zealand, Sweden, and the United Kingdom as well as from the World Economic Forum (WEF), gathered here to discuss the issues facing Smart Cities and Digital Government, and opportunities for growth within the landscape of digital disruption.

The two-day DGX will be complemented by site visits to Smart Nation Innovation Week's Innovfest Unbound, and to government agencies showcasing our Smart Nation journey.

DGX is jointly organised by the Smart Nation and Digital Government Office, and Government Technology Agency of Singapore.
